



**APPLICATION FOR CONSIDERATION OF
APPOINTMENT TO
TEMPORARILY UNOCCUPIED
CITY COUNCIL POSITION
BOCA RATON, FLORIDA**

The Boca Raton City Council is accepting applications from persons interested in temporary appointment to City Council Seat C, which is temporarily unoccupied due to the leave of absence for active military service requested by Council Member Jeremy Rodgers, pursuant to Chapter 115, Florida Statutes.

To qualify for appointment, applicants must be at least 18 years old, a resident of the City of Boca Raton, and a registered elector of the City.

The appointment to fill the temporarily unoccupied position would be for a term that would begin on the effective date of the appointment until March 31, 2021 or an earlier date, pursuant to Florida Statute 115.11(2), should Council Member Rodgers return from active military service prior to the end of his term, which will occur on March 31, 2021.

The City Council sits as the Community Redevelopment Agency (CRA) on Mondays. City Council Workshops are held immediately following the CRA meetings. City Council Regular Meetings are held on Tuesdays. City Council and CRA meetings, which the temporary appointee will be expected to attend, are scheduled for the following dates:

Pursuant to City of Boca Raton Emergency Order No. 2020-02, the Meeting will be a Virtual Meeting conducted using Communications Media Technology.
